RESOLUTION NO. 2-15

IN SUPPORT OF STATE OF WISCONSIN BEING CHARGED WITH MANAGING THE GRAY WOLF POPULATION HAVING A GOAL OF 350 OR LESS

WHEREAS, the Wisconsin Department of Natural Resources ("WDNR") established a gray wolf population goal of 350 animals in 1999, and reaffirmed this population goal in 2007, based on prey availability and human population density, and nothing has happened to increase prey availability or decrease human density in the intervening years; and

WHEREAS, the WDNR plans to review and possibly revise the previous wolf management plan, adopted in 1999 and revised in 2007; and

WHEREAS, the Wisconsin Wildlife Federation and Wisconsin Farm Bureau have officially approved a wolf goal of 350 or less; and

WHEREAS, the Wisconsin Conservation Congress Spring Hearings (2011) overwhelmingly supported a wolf population goal of 350 or less; and

WHEREAS, twenty-three (23) county boards in northern and west central Wisconsin have passed resolutions that recommend a Wisconsin wolf population goal of 350 (6) or 350 or less (17); and

WHEREAS, Wisconsin residents have experienced depredations and threatening incidents involving wolves, including 81 incidents to animals and 6 threats to human safety in 2013, occurring in 21 counties; and

WHEREAS, the high predator population, in particular wolves, has resulted in the reduction of the deer population where wolves are plentiful, reducing hunting opportunities, curtailed livestock and pleasure horse activities, and are a danger to pets and people; and

WHEREAS, we understand the Federal District Court for the District of Columbia has recently vacated a 2012 decision by the United States Fish and Wildlife Services, which delisted wolves as an endangered species, and this decision returns wolves in the Great Lakes Region, including Wisconsin, to the Federal Endangered Species List; and

WHEREAS, if and when wolves are again removed from the Federal Endangered Species List, we recommend having the State of Wisconsin charged with managing the wolf population in Wisconsin and that such goal be set at 350 or less.

NOW, THEREFORE, BE IT RESOLVED BY THE SHAWANO COUNTY BOARD OF SUPERVISORS in session this 25th day of February, 2015, that Wisconsin approve a population goal of 350 or less for gray wolves in the next revision of the Wisconsin Wolf Management Plan.

BE IT FURTHER RESOLVED that the WDNR and other partners implement meaningful population controls in the next Wisconsin Wolf Management Plan to bring the wolf population to goal levels; and

BE IT FURTHER RESOLVED the WDNR not relocate wolves that have caused problems in Wisconsin or other areas, to places within Wisconsin.

BE IT FURTHER RESOLVED that a certified copy of this resolution be sent to the WDNR Secretary, DATCP Secretary, Governor Scott Walker, and applicable state and federal legislators.
