Opposing 2017 Senate Bill 777 and 2017 Assembly Bill 923 Relating to Increasing the Authority of a County Executive from a Populous County and Other Counties and Reducing the Authority of a County Board

1 2	Moved/Sponsored by: Executive Committee
3 4 5 6	WHEREAS, the Walworth County Board of Supervisors and the County Administrator have successfully worked together for many years achieving fiscal responsibility and providing innovative programs; and,
7 8 9	WHEREAS, proposed 2017 Senate Bill 777 ("SB 777") and 2017 Assembly Bill 923 ("AB 923") make a number of changes to laws relating to the authority of county executives and administrators and county boards; and,
11 12 13 14 15	WHEREAS, SB 777 and AB 923 generally provide that any power conferred to a county executive or administrator must be broadly and liberally construed and limited only by express language, and that, to the extent that a conflict exists between county board action and county executive or administrator action, the action of the executive or administrator shall prevail, to the extent of the conflict; and,
17 18 19	WHEREAS, SB 777 and AB 923 change the authority of county executives and county boards statewide relative to acceptance of donations, gifts, and grants, and transportation leases; and,
20 21	WHEREAS, SB 777 and AB 923 restrict county board actions related to the budget; and,
22 23 24	WHEREAS, SB 777 and AB 923 allow the county executive or administrator to determine whether to utilize biennial budgeting; and,
25 26 27 28	WHEREAS, SB 777 and AB 923, generally, fundamentally expand the powers that may be exercised by the county executive and administrator and limit the powers that may be exercised by a county board; and,
29 30 31 32	WHEREAS, the Walworth County Board of Supervisors is strongly opposed to any provisions that would significantly change the current powers of county boards, executives and administrators; and,
33 34 35 36	<b>WHEREAS</b> , the policy changes in SB 777 and AB 923 have not been properly vetted nor has the general public been properly informed of the shift in the balance of power among their local elected officials.
37 38 39	<b>NOW, THEREFORE, BE IT RESOLVED</b> that the Walworth County Board of Supervisors hereby expresses its opposition to 2017 Senate Bill 777 and 2017 Assembly 923.
